With reference to Prime minister's vision to youth led development under Ministry of Youth Affairs and Sports, Government of India and instructions to ensure the establishment of scouts/guides unit in every school, the undersigned has pleased to introduce Scouting/Guiding activities among the students of your school under ongoing programme "Scouting for All". In this era, the Organization feels proud to include multifarious topics in new syllabus i.e Yoga, Self Defense Sanskar Classes, Jam Radio and opportunity to contact with astronaut NASA.

That the Concept and ideal of scouting and guiding is a brain child of Robert Stephenson Baden Powell, who has created a programme for providing variety of training to young boys and Girls. Initially these scouting/guiding activities were confined to England but with the passage of Time the activities spread in deferent countries of the world. It is a Services Organization. comprising the Army style, engaged in grooming the youth of the country into disciplined and patriotic citizen, Its came into existence with the following aims:-

- > Development of leadership, character, comradeship and the ideals of service.
- > Stimulation of interest in the peace of the country, to the country, to the widest possible extent.
- Building up of a reserve of potential officers to enable the Armed Forces to expand rapidly in a national emergency.

Enrolment- Induction into the Scout/Guides is on compulsory basis and students both boys/girls can join at the age of 11 years onward. With the educational purpose of the Scout Movement whose aim is to assist young. People in the full development of their potentials. The Organization shall be planned to organize the training programme, seminar and other activities time to time among the youths under the implementation of instruction issued by Ministry of Youth Affairs \$ Sports Government of India. A Permanent Scouts/Guides unit should be established in your school and that Scout Master/Guide Captain would impart the training regularly for 4 years.

NOMINAL FEE PER STUDENT 100/-(RUPEES ONE HUNDRED ONLY PER MONTH).

ONE TIME REGISTRATION FEE PER HEAD RUPEES 200/-(RUPEES ONE HUNDRED ONLY).

REGISTRATION FEE FOR SCHOOL 520/-(RUPEES FIVE HUNDRED TWENTY) FOR ONE YEAR

RENUWAL REGISTRATION CHARGES FOR ONE YEAR 100/- (RUPEES ONE HUNDRED ONLY)

The sanction has been meant for the following purposes-

- 1. The basic training imparted to all the students at 3 formative stages with a gap of six months
- 2. If the total number exceeds 800. A permanent teacher will be deployed for your school.
- 3. The Certificates and other facilities given to all participants.
- 4. The Participants should be able to qualify "Rajya Puraskar and National Award".
- 5. The Students would be entitle to get all the privilege under Government of India and State Government.
- 6. Get the privilege of meeting the HE President of India.

Therefore, it is requested to kindly enforce the scouting/guiding activities in your school curriculum and send a list of Participating boys and girls along with their enrolment fees as soon as possible. The DD may by issued in the favor of "Hindustan scouts & guides" payable.
